Re: Coordination with the Oklahoma State System of Higher Education

This letter acknowledges receipt of your letter and documentation from the Higher Learning Commission (HLC) to add a new degree site at Fort Sill Army Base in Fort Sill, Oklahoma. Accreditation policy in Oklahoma requires institutions offering programs to be accredited by a regional or national accrediting agency recognized by the United States Department of Education or the State Regents. This office recognizes the accreditation status of Upper Iowa University (UIU) with the Higher Learning Commission. UIU is requesting this recognition to allow the enrollment of military members when classes begin in July 2010.

The information provided below acknowledges authorization to operate in Oklahoma. State Regents recognition and approval is not required for institutions operating on military bases to serve personnel and dependents. However, the State Regents are appreciative that UIU has coordinated with us, and it will be helpful if UIU ever chooses to offer degrees to civilian students.

It is required that accredited institutions report changes regarding the accreditation status or offerings (i.e., new programs, negative accreditation commission action). Institutions that do not report changes risk interrupting their approval status with the State Regents. Copies of accreditation reports are now required by State Regents' policy.
